SCHEDULE "LS" LIGHTING SERVICE

TAX ADJUSTMENT:

Billing under this schedule may be increased by an amount equal to the sum of the taxes payable under the Gross Receipts and Compensating Tax Act and of all other taxes, fees, or charges (exclusive of Ad Valorem, State and Federal Income Taxes) payable by the Cooperative and levied or assessed by any governmental authority on the public utility service rendered, or on the right or privilege of rendering the service, or on any object or event incidental to the rendition of the service.

MINIMUM CHARGES:

The minimum billing period charges shall be at the net rate per billing period for wattages quoted, or as established by contract in accordance with the Cooperative's Line Extension Policy or as established in the above rate schedule.

LIMITED INVESTMENT:

The maximum investment by the Cooperative per lighting installation shall be either (1) the cost of the fixture, installation and connection where the installation is made on an existing Cooperative-owned structure, or (2) as provided by the Cooperative's Line Extension Policy where additional poles, wiring or other electric plant is required to serve the light.

TERMS OF PAYMENT:

The charges per billing period in the foregoing rates are net, and due and payable upon receipt. Charges are past due if not paid within twenty (20) days from the date on the bill.

SERVICE CHARGE:

A service charge of one and one-half percent (1-1/2%) per billing period or fraction thereof will be charged on all utility service bills and invoices which are delinquent.

CONDITIONS OF SERVICE:

- (1) Lighting installations and related appurtenances shall be owned, operated and maintained by the Cooperative. All facilities installed on the consumer's premises shall be the property of the Cooperative.
- (2) Lighting installations shall require a 60 continuous months (5 years) service agreement, or as provided by the Cooperative's Line Extension Policy.

SCHEDULE "LS" LIGHTING SERVICE

- (3) Lighting installations shall be controlled by light sensitive photo-electric cells.
- (4) Lighting installations shall be maintained by the Cooperative only during normal working hours.
- (5) Lighting installations may be inoperative during periods within a month, but such periods shall not cause the net rate per billing period to be adjusted.
- (6) The Cooperative reserves the right to remove lamp and appurtenances at any time in the event more than two calls per year become necessary due to vandalism or other causes over and above regular maintenance required, unless the consumer agrees to pay for the additional calls and cost incurred to the lighting under his custody and control.
- (7) It shall be the consumer's responsibility to notify the Cooperative if lamp or fixture maintenance is required.
- (8) The consumer shall be subject to the rules and regulations of the Cooperative.
- (9) Special conditions of service shall be covered by contracts.

FUEL AND PURCHASED POWER COST ADJUSTMENT:

The Cooperative shall, if the purchased power expense is increased or decreased above or below the base purchase power cost of \$0.070004/kWh sold, flow through to the users such increases or decreases, in accordance with 17.9.550 NMAC.

DEBT COST ADJUSTMENT:

Billings under this schedule may be increased or decreased by the change in current debt cost utilized in establishing the present rates, in accordance with 17.9.540.16 NMAC.
